Preface

Eurostat's mission is to provide the European Union with a high-quality statistical information service. Within this framework, Eurostat makes available trade statistics of the European Union as a whole and of its Member States.

The aim of this new publication is to provide an overview of the main characteristics in the trade of the enlarged European Union. All the series between 1999 and 2004 have been recalculated to include the 10 new Member States; therefore figures published here concern the 25 Member States.

Chapter 1 shows the place of the European Union in global trade. Chapter 2 focuses on the structure and evolution of the external trade of the European Union as a whole. Chapter 3 highlights some key facts of euro-zone trade. Chapter 4 covers the trade of each Member State, including trade between Member States.

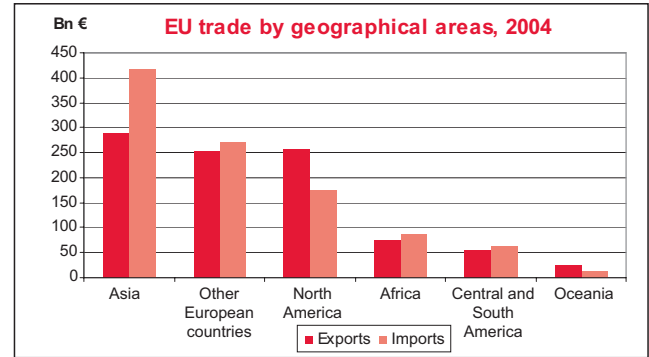
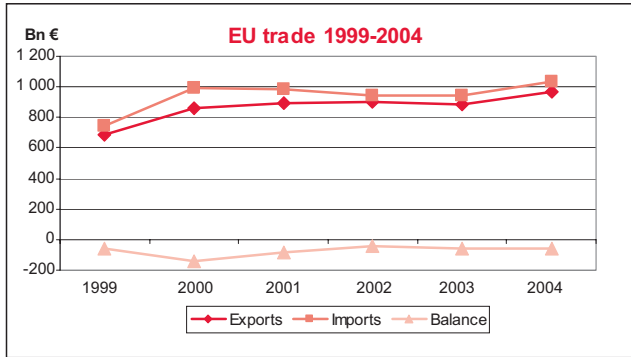
- The value of world trade in goods, excluding the intra-EU-25 trade, was more than EUR 5 000 billion in 2004. The European Union is the leading trader, accounting for 18 % of total world trade. The United States was the second biggest trader, with a share of 17 %, followed by China (9 %), Japan (8 %) and Canada (4 %).
- The EU is the biggest exporter and the second biggest importer in the world. In 2004, the value of extra-EU-25 exports was EUR 969 billion and the value of imports was EUR 1 032 billion.
- The United States is the biggest importer in the world. It also records the biggest trade deficit: almost EUR 569 billion in 2004.
- China has become a major global trader in recent years. In 2004, China overtook Japan as the third biggest trader in the world.

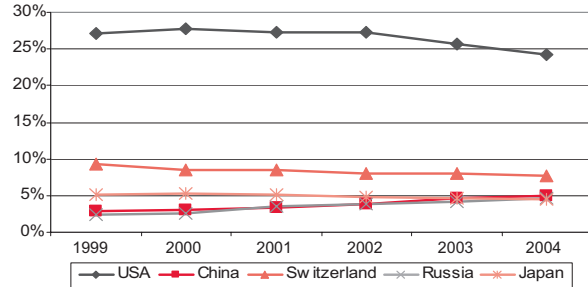
- After a strong growth at the turn of the millennium, the European Union recorded only a slight growth in exports and a small decrease in imports between 2000 and 2003. Trade recovered in 2004, as both exports and imports grew by 10 % from the previous year.
- EU trade is characterised by a permanent but generally limited trade deficit. In 2004, the deficit reached EUR 63 million, which was slightly higher than in the previous year but less than half the record deficit of 2000.
- In 2004, over 40 % of EU imports came from Asian countries, while the other European countries accounted for more than a quarter.
- The main destination for EU exports is Asia with a 30 % share, followed by North America and other European countries (both having a 26 % share).
- The EU has a considerable deficit in trade with Asian countries. After a peak in 2000, the deficit decreased in 2001 and 2002 as a result of a weaker demand for imports, but it has been rising again since 2003.
- The largest surplus is recorded in trade with North America.

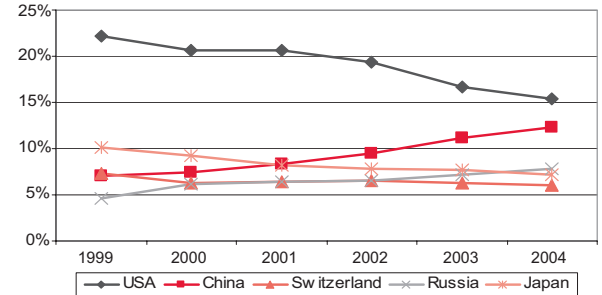

Main trading partners' shares of EU imports, 1999-2004

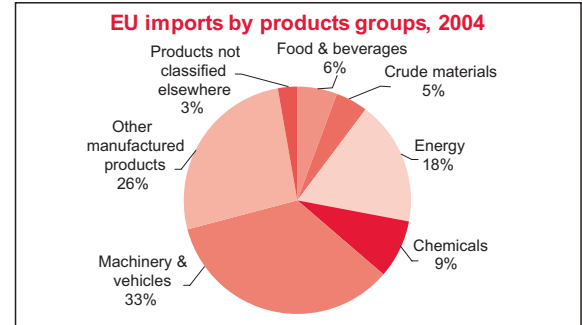
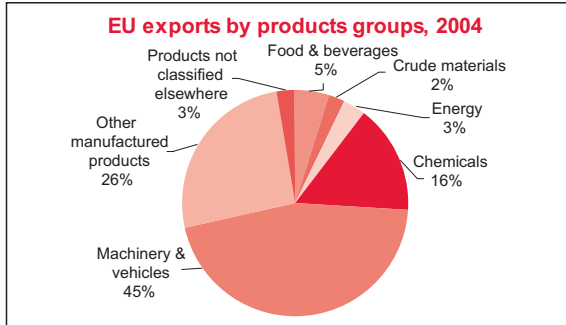


- The United States has traditionally been the most important trading partner of the EU but its relative significance has declined in recent years, in particular for imports. Between 1999 and 2004, the USA's proportion of total EU exports fell from 27 % to 24 % and of imports from 22 % to 15 %. The surplus in trade with the USA grew every year and reached EUR 76 billion in 2004.
- China has become a main player in world trade in recent years. EU trade with China has more than doubled since 1999. China ranks currently second among the trading partners of the EU, after overtaking Switzerland and Japan in 2003.
- Since 2000, the EU has recorded the largest bilateral deficit in trade with China. Other large deficits were measured in trade with Russia, Japan and Norway. The EU posts the only large-scale trade surplus in trade with the USA.

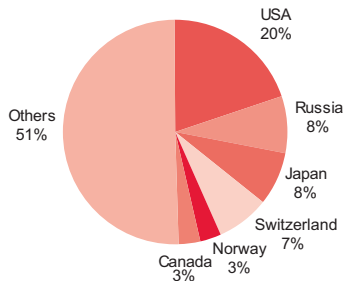
- The EU exports mainly manufactured products: their share has annually been around 87 % of the total EU exports. In 2004 machinery and vehicles made up almost half of the total exports whilst other manufactured products accounted for 26 % and chemical products 16 %.
- Primary products account for 10 % of total exports; half of this is food and beverages.
- The structure of imports has slightly changed in recent years. Between 1999 and 2004 the share of primary products increased from 23 % to 28 % while the respective share of manufactured products declined. The main reason behind this is the rapid growth of imports of energy products.
- More than two thirds of the imports are manufactured goods. The breakdown diverges from exports: machinery and vehicles and chemical products account for a smaller share whilst the other manufactured products are more important.
- The surplus in trade of manufactured goods grew nearly threefold from 1999 to 2004. The trade of primary products showed an opposite development: while the deficit in agricultural products and crude materials remained fairly stable, the deficit in energy products more than doubled.

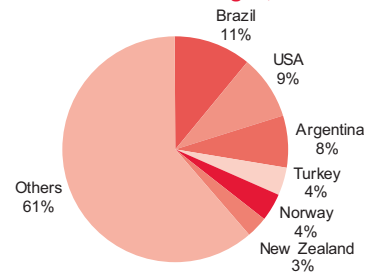

Main trading partners' shares of EU imports of food and beverages, 2004

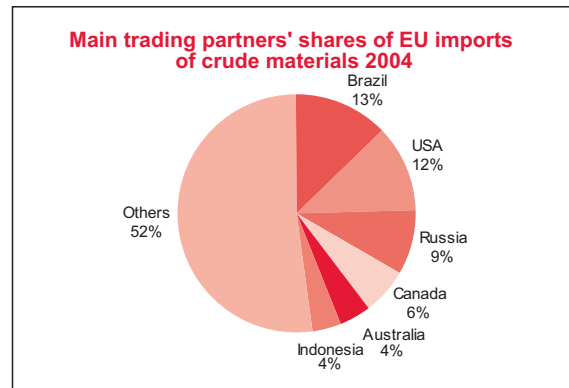
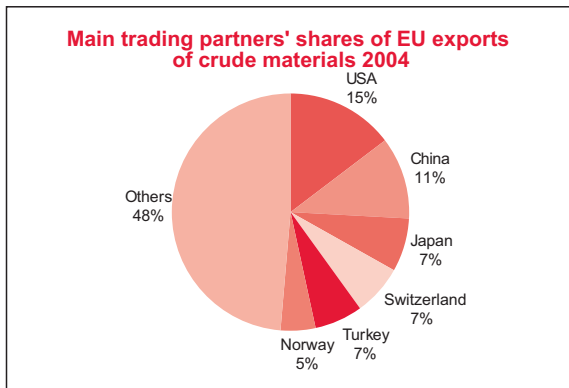


- The product group 'food and beverages' (SITC, Sections 0 and 1) includes agricultural products such as food and live animals, beverages and tobacco.
- Trade in food and beverages remained fairly stable between 1999 and 2004. The EU posted a permanent trade deficit — annually between EUR 6.6 billion and EUR 9.4 billion — during the same period.
- In exports, beverages are the most important individual products within the group, accounting for more than a quarter of the total. Other main products include dairy products, fruits, vegetables and cereals.
- The USA is the main destination country for the EU exports, with a 20 % share, followed by Russia, Japan and Switzerland.
- Coffee and tea, fruits, vegetables and fish and make up almost 60 % of the imports.
- The imports of food and beverages are less concentrated than total EU imports. Brazil, the USA and Argentina are the only suppliers accounting more than 5 % of total imports.

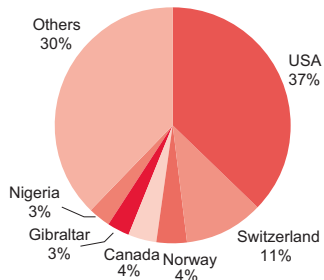
- Crude materials (SITC, Sections 2 and 4) include non-manufactured goods like oilseeds, cork, wood, pulp, textile fibres, ores and other minerals, as well as animal and vegetable oils.
- The EU has an ongoing trade deficit; imports had more than twice the value of exports in 2004.
- One third of imports are metal ores. Other products to record a large share of imports include cork, wood and oilseeds.
- The USA was the most important supplier of the EU imports until 2004, when Brazil took over. Russia and Canada are the other main partner countries.
- EU exports in crude materials are relatively low as they make up only 2 % of the total exports. As for imports, metal ores, cork and wood are the main products traded.

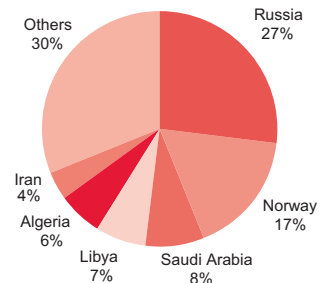

Main trading partners' shares of EU imports of energy products, 2004



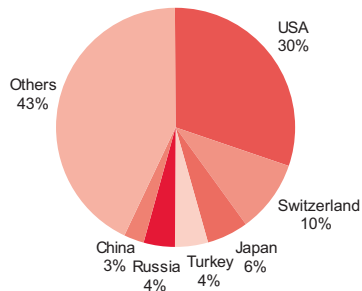
- The main goods of energy products (SITC, Section 3) are crude oil, refined petroleum products, coal, gas and electric current.
- The EU is dependent on imports of energy products. This has led to a structural trade deficit, which reached a record level of EUR 148.5 billion in 2004.
- The value of imports follows closely the price of crude oil. EU imports almost doubled from 1999 to 2000, then remained fairly stable from 2000 to 2003 and rose by 16 % in 2004.
- Three quarters of imports are petroleum and petroleum products, mainly crude oil. Most of the remainder falls to gas and coal.
- The most important energy providers of the EU are Russia and Norway, which made up almost half of the imports in 2004. Saudi-Arabia, Libya and Algeria have also an important role as energy suppliers to the EU.
- The majority of the EU exports are refined petroleum products. The biggest destination country is the USA, which accounts for more than one third of the total exports.

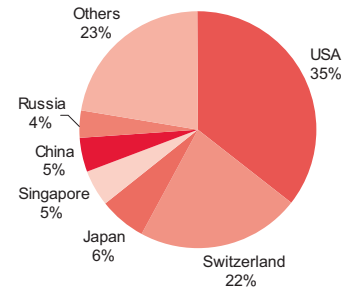

Main trading partners' shares of EU imports of chemical products, 2004



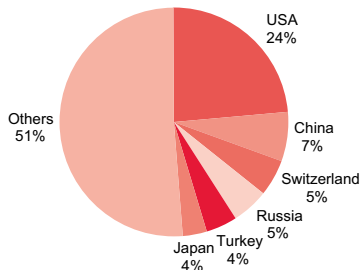
- The chemicals sector (SITC, Section 5) contains various chemical goods such as organic chemicals, inorganic chemicals, plastics and pharmaceutical products.
- Trade in chemicals has grown steadily every year since 1999, except for 2003. The sector's share of the total EU trade has also increased: in 2004, chemicals accounted for 16 % of exports and 9 % of imports.
- Besides machinery and vehicles, the chemicals sector is the only product group where the EU posts a trade surplus. The surplus reached EUR 64.6 billion in 2004.
- The most important products within the group, both for exports and imports, are pharmaceutical products and organic chemicals.
- The majority of imports come from a small number of countries: in 2004, the six biggest suppliers accounted for over three quarters of the total EU imports. The USA was the main source, with a proportion of 35 %, followed by Switzerland with 22 %.
- For exports, the USA (30 % in 2004) and Switzerland (10 %) were also the main partner countries.

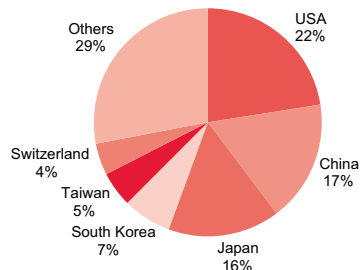

Main trading partners' shares of EU imports of machinery and vehicles, 2004



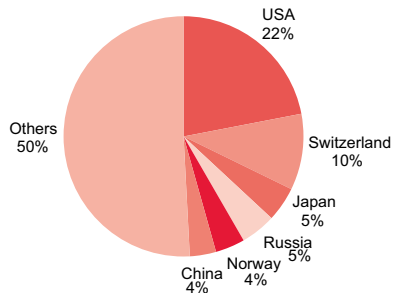
- Machinery and vehicles (SITC, Section 7) includes power generating and industrial machinery, computers, electric and electronic parts and equipment, road vehicles and parts, ships, airplanes and railway equipment.
- Machinery and vehicles is the most important individual product group in the external trade of the EU, accounting for 45 % of the total EU exports and over one third of the imports in 2004. The group records also the largest surplus in EU trade: EUR 83 billion in 2004.
- The main exported products within the group are road vehicles, electrical machinery and industrial machinery while the imports are dominated by electrical machinery, IT products and telecommunications equipment.
- The USA is by far the biggest destination country for the EU exports, although its proportion diminished from 30 % to 24 % between 1999 and 2004. Concerning the other main partner countries, exports to China, Russia and Turkey increased strongly during the same period while exports to Switzerland and Japan remained stable.
- The USA and Japan are still two of the top three source countries for imports although their importance has decreased. In 1999, they covered over half of the EU imports but only 38 % in 2004. During the same period, China's share increased from 6 % to 17 %. In 2004, these three countries together accounted for 56 % of the EU imports.

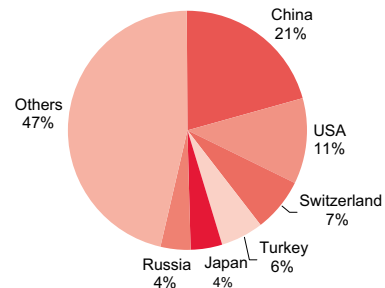

Main trading partners' shares of EU imports of other manufactured products, 2004



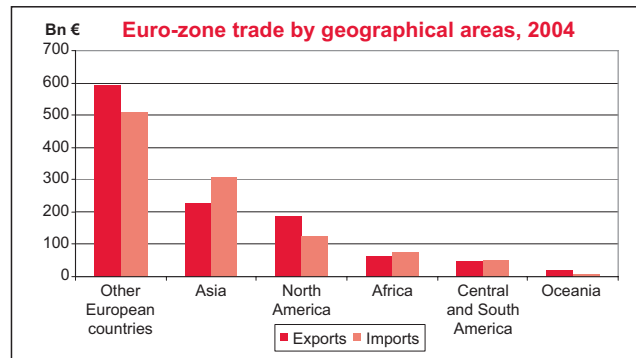
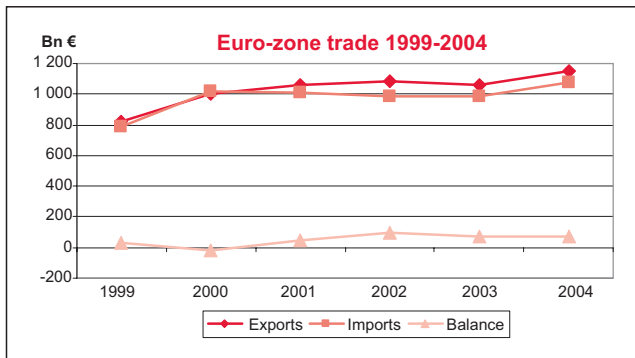
- Other manufactured products (SITC, Sections 6 and 8) is a heterogeneous group consisting of manufactured products which range from basic semi-manufactured products such as leather, rubber, wood, paper, textiles, metals, building fixtures and fittings to more labour-intensive products like clothes, shoes and accessories, scientific instruments, clocks, watches and cameras.
- The structure of exports and imports, in terms of products, differs to some extent. The EU exports more semi-manufactured products, such as metals and metal products, while imports are dominated by miscellaneous manufactured products, in particular clothing.
- After a relatively stable development between 2000 and 2003, the value of both imports and exports rose in 2004 by 10 % on the previous year. Since 1999, the EU has posted a trade deficit, annually between EUR 12 million and EUR 29 billion.
- After overtaking the USA in 2001, China has been the biggest supplier to the EU in this product group. Other important suppliers include the USA, Switzerland and Turkey. The main destinations for exports are the USA, Switzerland, Japan and Russia.

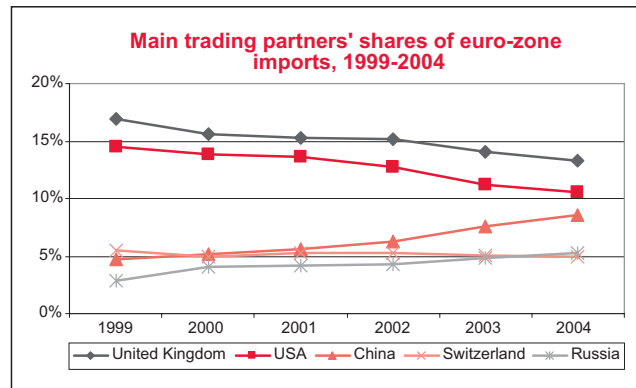
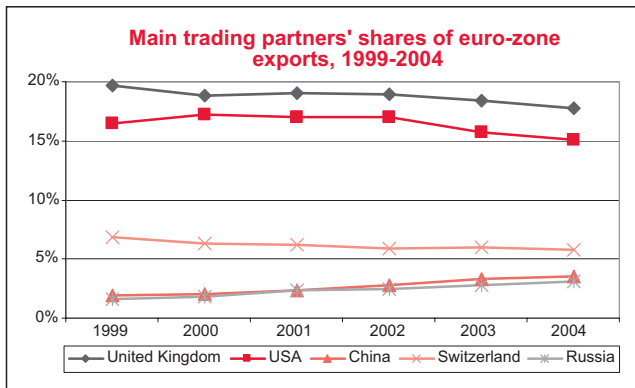


- Euro-zone trade has followed the same pattern as EU trade in recent years: the value of trade increased strongly from 1999 to 2000, then remained fairly stable until 2003. In 2004, the value of both imports and exports grew by 9 % from the previous year.
- About half of euro-zone trade is carried out with other European countries. In 2004, they accounted for 52 % of exports and 47 % of imports. The respective shares of Asian countries were 20 % and 29 %.
- Unlike the EU as a whole, the euro-zone has posted a trade surplus since 2001. The euro-zone runs a surplus in trade with other European countries and North America, while a deficit is recorded in trade with Asian countries.

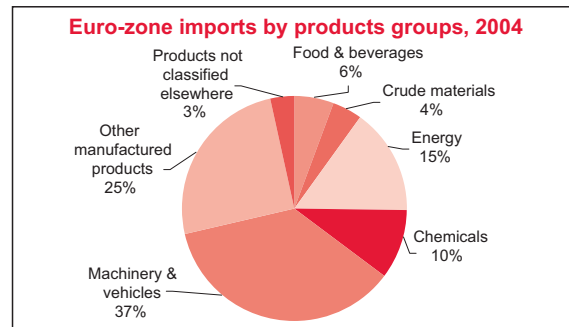
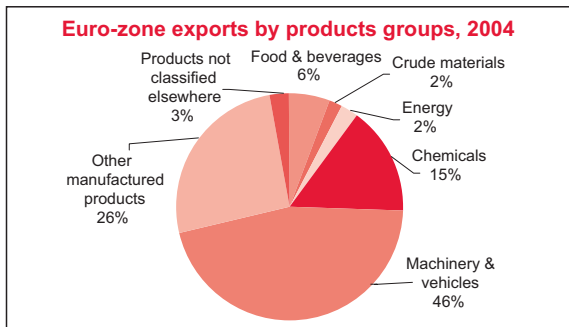


- The most important trading partner of the euro-zone is the United Kingdom, followed by the United States. In 2004, the United Kingdom accounted for 18 % of exports and 13 % of imports, while the USA recorded 15 % and 11 % respectively.
- The euro-zone is running a growing surplus in trade with the United Kingdom and the USA. In 2004, the surplus with the United Kingdom reached EUR 61.8 billion, up from EUR 28 billion in 1999. The surplus with the USA grew from EUR 21 billion to EUR 59.5 billion during the same period.
- Trade with China has grown strongly in recent years. In 2004, China was the third largest partner. As imports from China grew at a faster pace than exports, the trade deficit deepened to EUR 52.2 billion in 2004.
- Besides China, large deficits are also recorded in trade with Russia and Japan.

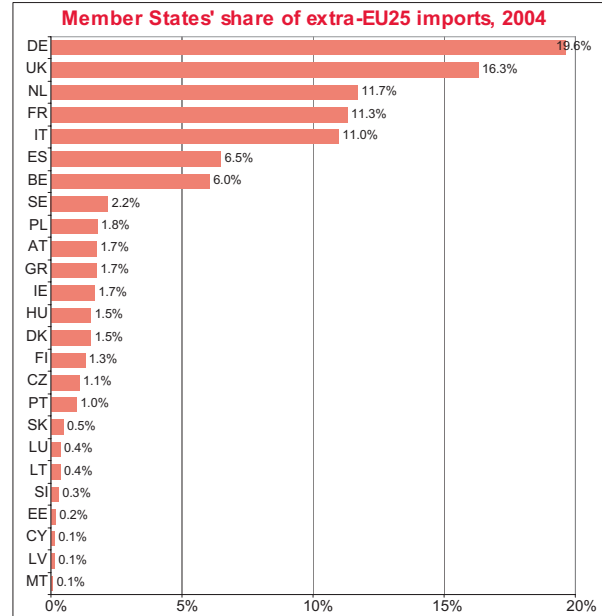
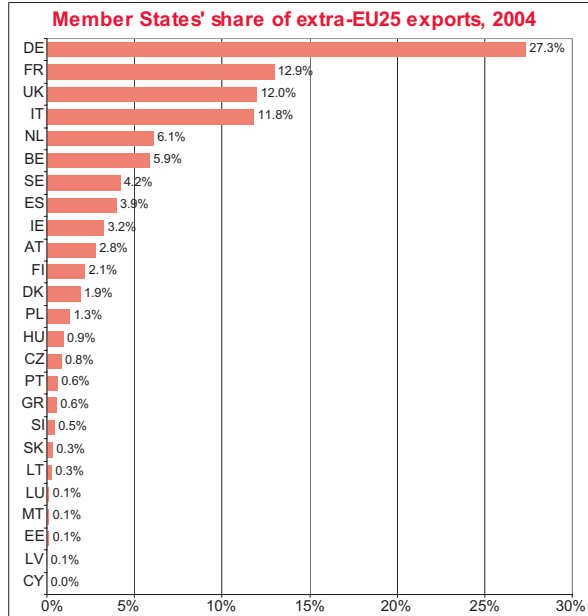

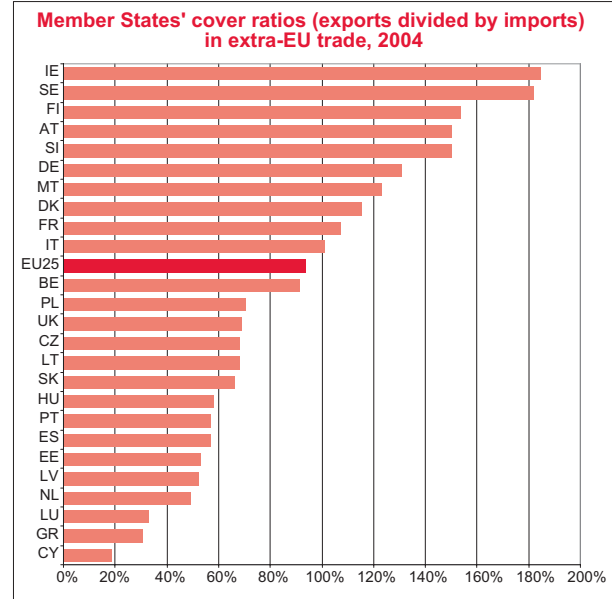
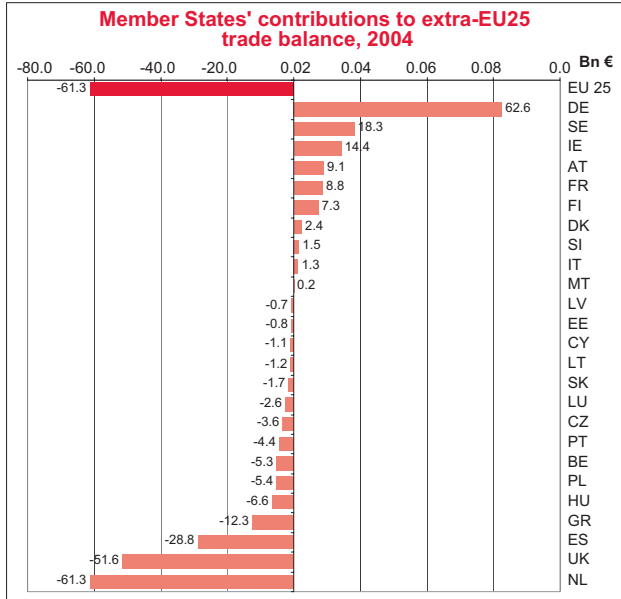


- The structure of euro-zone trade, in terms of products, is very similar to that of the EU. Exports are concentrated on manufactured products. In 2004, machinery and vehicles made up 46 % and other manufactured products 26 % of total exports.
- For imports, the primary products accounted for one quarter of total imports. A major share of this was made up by energy products.
- The euro-zone is running a substantial surplus in manufactured products. In 2004, the surplus was EUR 229 billion. Over half of this was generated by machinery and vehicles, while chemicals and other manufactured products were also accumulating a surplus.
- Trade of primary products is running a sizeable deficit. While trade in food and beverages posts a small surplus, there is a permanent deficit on energy products and crude materials.

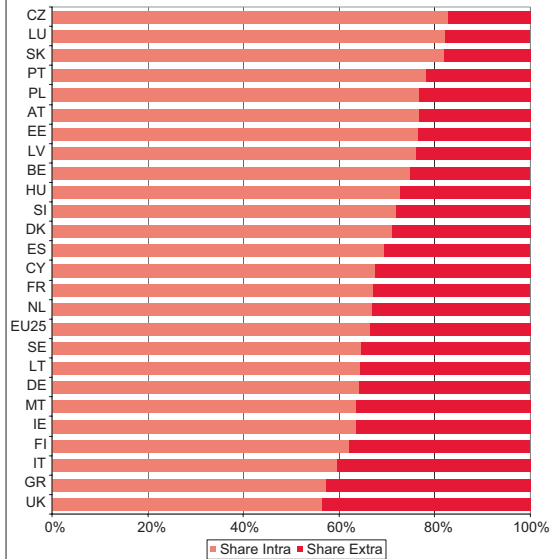

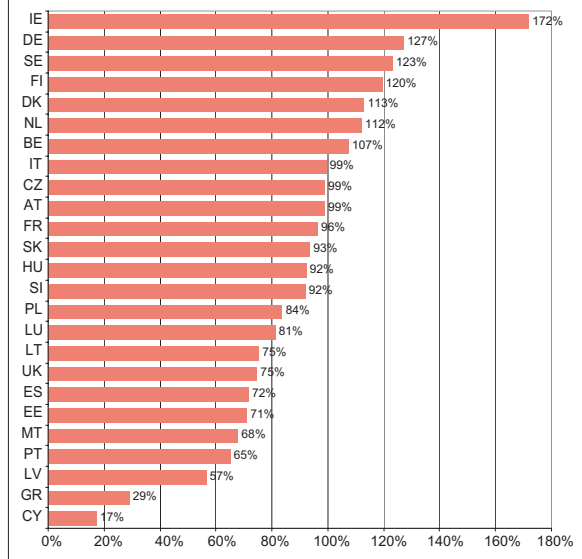




Shares of intra-EU and extra-EU trade in total trade, 2004

5. Methodological notes

Coverage

Series concerning the European Union were recalculated to include the Czech Republic, Cyprus, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia and Slovenia; therefore figures published here concern the 25 Member States.

Statistical territory

The statistical territory of the European Union corresponds to the customs territory of the European Union.

Extra-EU trade

Statistics on trade with third countries cover movable property imported and exported by the European Union. The definitions are as follows.

- Imports are goods which enter the statistical territory of the European Union from a third country and are placed under the customs procedure for free circulation (as a general rule goods intended for consumption), inward processing or processing under customs control (goods for working, processing or repair) immediately or after bonded warehousing.
- Exports are goods which leave the statistical territory of the European Union for a third country after being placed under the customs procedure for exports (definitive export) or outward processing (goods for working, processing) or repair or following inward processing.

Intra-EU trade

Statistics on trade between the Member States cover the arrivals and dispatches of movable goods recorded by each Member State. Arrivals and dispatches are defined as follows.

- Arrivals are goods in free circulation within the European Union which enter the statistical territory of a given Member State.
- Dispatches are goods in free circulation within the European Union which leave the statistical territory of a given Member State to enter another Member State.

Trading partners

The results are broken down by country in accordance with the 'Country nomenclature for statistics on European Union external trade and trade between

its Member States', referred to as the 'Geonomenclature' (Geonom).

In the case of exports (or dispatches), the country (or Member State) of final destination of the goods is the partner country.

The trading partner in the case of an intra-European Union arrival is always the country of consignment of the goods, even when the goods originate in third countries and have been placed in free circulation in the country of consignment. For imports (extra-EU trade), the statistics show, except in certain cases (returned goods, works of art, etc.), the country of origin. Trade recorded under the category 'non-specified' in Tables 2.1 and 3.1 includes trade which cannot be allocated to an individual partner country due to confidentiality, adjustments or data errors.

Dutch imports, and therefore the trade deficit, are over-estimated because of the 'Rotterdam effect', where goods destined for the rest of the EU arrive and are recorded in harmonised EU external trade statistics in Dutch ports. This then has a positive effect on the external trade balances with the third countries of those Member States to which the goods are re-exported, as these shipments would be recorded as intra-EU trade with the Netherlands, rather than extra-EU trade with the third countries.

Goods classification

The most detailed results published by Eurostat are broken down according to the subheadings of the Combined Nomenclature (CN). This tariff and statistical nomenclature is based on the international nomenclature of the Harmonised System (HS) and comprises around 10 000 eight-digit codes.

In this publication, the results are broken down by the sections of the UN standard international trade classification (SITC Rev. 3 since 1988) by means of conversion tables drawn up by Eurostat on the basis of the CN.

Statistical value

For extra-EU trade, the statistical value is based on the customs value or, failing that, the transaction value of the goods. For intra-EU trade, it is based on the assessment basis for taxation purposes or the transaction value of the goods.

It is the fob (free on board) value for dispatches and exports and the cif (cost, insurance, freight) value

for arrivals and imports. It comprises only those subsidiary costs (freight and insurance) which relate, for dispatches and exports, to the journey within the territory of the Member State from which the goods are dispatched and, for arrivals and imports, to the journey outside the territory of the Member State into which the goods enter.

In the case of trade under an inward or outward processing arrangement and those for outside processing, it is always the total value of the goods that is recorded and not simply the added value.

Although the data are collected in units of national currency, the values set out in this publication have been expressed in euros.

Data sources

The tables in this publication on EU trade and that of the Member States were compiled by Eurostat using the detailed data forwarded by the Member States. The data is based on the data available on **12 October 2005**. Table 1 describes the development of external trade as declared by some of the EU's most important trading partners. Data in this table is taken from the WTO database on the internet.
